## **Disbursements**

Disbursements are items arranged for and possibly paid for on your behalf. You will be expected to pay for these items at the time the contract is entered. The following are some items that are often identified as disbursements.

Coroner's fee (\$75) - This is a fee charged by the coroner for issuing a certificate that allows cremation to take place. The fee is set by the Chief Coroner for Ontario.

**Newspaper notices** - These are charges for death notices placed in local or out of town newspapers.

Municipal death registration fee - This is a fee charged by the local municipality to register the death. The fee is set by the municipality and may vary. (\$37)

**Forest Lawn Crematorium (\$530)** – This is a fee charged by the Crematorium for providing the cremation of human remains (amount cannot be pre-paid to Ranger's Cremation and Burial Services Ltd.)

**Cooperative Crematorium (\$725)** - This is a fee charged by the Crematorium for providing the cremation of human remains (amount cannot be pre-paid to Ranger's Cremation and Burial Services Ltd.)

### **Payment**

You will be required to pay in full at the time of signing the contract for services. Amounts outstanding after that date will be ar interest at the rate of 1.5% per month (19.56% APR), calculated daily and compounded monthly, from the due date until paid in full. Payment may be made by debit, cash, cheque, Visa or MasterCard. There will be a charge of \$40.00 for any non-sufficient funds (NSF) cheques returned by the bank. Any costs of collection shall be the responsibility of the purchaser.

## **Pre-payment options**

For your convenience, we offer the option of prepaying services. When prepaying, you pay for the requested services and the funds will be used to pay for these services when they are delivered at the time of death

#### Trust

The funds will be placed in trust with Guaranteed Funeral Deposits (GFD) and will accrue interest until the contract is fulfilled (when the services are delivered) or the contract is cancelled. Additional information about funding, payment and financing options is available on request.
